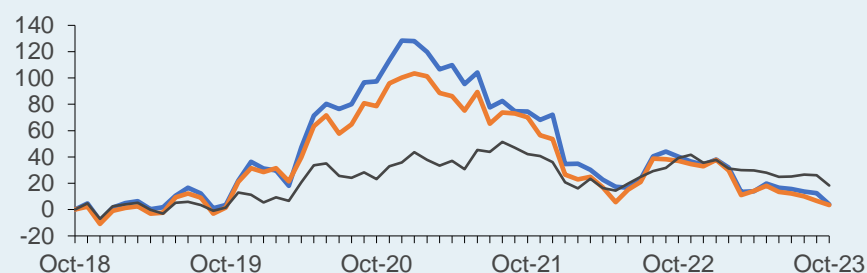

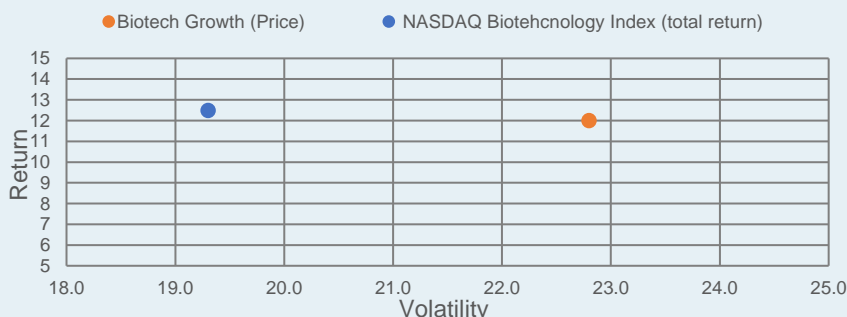

### Investment Policy

In order to achieve its investment objective, the Company invests in a diversified portfolio of shares and related securities in biotechnology companies on a worldwide basis. The Company will not invest more than 15% of the value of its gross assets in any one individual stock at the time of acquisition. No more than 10% of gross assets will be invested in unquoted investments at the time of acquisition. This limit includes any investment or commitment to invest in private equity funds managed by OrbiMed or an affiliate thereof. Investments or commitments to invest in such private equity funds will be limited to US\$15m, after the deduction of proceeds of disposal and other returns of capital. The Company's borrowing policy is that borrowings will not exceed 20% of value of the Company's net assets. The Company may be unable to invest directly or efficiently in certain countries or share classes. In these circumstances, the Company may gain exposure by investing indirectly through swaps or other derivative instruments. Exposure to these financial instruments will count towards and be subject to the following limits: Derivative transactions (excluding equity swaps) can be used to mitigate risk and/or enhance return and will be restricted to an aggregate net exposure of 5% of the value of the gross assets measured at the time of the relevant transaction; Equity swaps may be used for efficient portfolio management purposes and aggregate net counterparty exposure through a combination of derivatives and equity swap transactions is restricted to 12% of the value of the gross assets of the Company at the time of the transaction.

#### Commentary

In October, the NAV per share was down 2.9%, the share price was down 7.5% and the benchmark NASDAQ Biotechnology Index (sterling adjusted) was down 6.1%.

Biotech's pullback continued in October, as equity markets came under pressure amid tax-loss selling and a continued rise in 10-year U.S. government bond yields. Unprofitable technology companies, including emerging biotech, remained under pressure. We continue to believe that we are in the final stages of Federal Reserve interest rate increases and that the 10-year yield has likely plateaued.

There were several notable M&A deals announced in October. Eli Lilly acquired Point Biopharma Global, a developer of radiotherapeutics for cancer, for ~\$1.4bn. Kyowa Kirin announced its intention to purchase Orchard Therapeutics, a gene therapy company, for \$387mm. Roche also announced its intention to buy Telavant, a company set up by Roivant and Pfizer to develop a promising inflammatory bowel disease treatment, for \$7.1bn. The Company had direct exposure to one M&A transaction that was announced in October: Bristol Myers Squibb's deal to buy precision oncology company Mirati Therapeutics for ~\$4.8bn. The Company had just purchased shares in Mirati in a financing in August based on new data for the company's PRMT5 inhibitor for cancer. We continue to expect robust M&A activity in the emerging biotech space given Big Pharma's urgency to acquire new biotech drugs to offset expected revenue losses from patent expirations of key products.

Scholar Rock Holding, ALX Oncology Holdings, and Mirati Therapeutics were the largest positive contributors to performance during the month. Scholar Rock outperformed in October after it announced it will advance SRK-439, a highly selective myostatin inhibitor, for use in combination with GLP-1 based weight loss agents to preserve lean muscle mass. ALX Oncology's stock price rose after the company announced positive interim results from a Phase 2 study evaluating evorpacept in gastric cancer. Mirati's shares appreciated after Bristol Myers Squibb announced the acquisition of the company.

Immatics, Vera Therapeutics, and Sarepta Therapeutics were the largest negative contributors to performance during the month. Share prices of Immatics and Vera fell on no fundamental news. Sarepta stock sold off after the company announced it missed the primary endpoint of a Phase 3 trial evaluating its gene therapy, Elevidys, to treat young patients with Duchenne muscular dystrophy. However, Elevidys did achieve statistical significance on all key secondary endpoints of the trial, suggesting a pathway to full approval of the therapy could still be possible.
