

Investment Policy

In order to achieve its investment objective, the Company invests in a diversified portfolio of shares and related securities in biotechnology companies on a worldwide basis. The Company will not invest more than 15% of the value of its gross assets in any one individual stock at the time of acquisition. No more than 10% of gross assets will be invested in unquoted investments at the time of acquisition. This includes any investment or commitment to invest in private equity funds managed by OrbiMed or an affiliate thereof. Investments or commitments to invest in such private equity funds will be limited to US15m, after the deduction of proceeds of disposal and other returns of capital. The Company's borrowing policy is that borrowings will not exceed 20% of value of the Company's net assets. The Company may be unable to invest directly or efficiently in certain countries or share classes. In these circumstances, the Company may gain exposure by investing indirectly through swaps or other derivative instruments. Exposure to these financial instruments will count towards and be subject to the following limits: Derivative transactions (excluding equity swaps) can be used to mitigate risk and/or enhance return and will be restricted to an aggregate net exposure of 5% of the value of the gross assets measured at the time of the relevant transaction; Equity swaps may be used for efficient portfolio management purposes and aggregate net counterparty exposure through a combination of derivatives and equity swap transactions is restricted to 12% of the value of the gross assets of the Company at the time of the transaction.





Commentary

In July, the NAV per share was up 4.5%, the share price was up 4.4% and the benchmark NASDAQ Biotechnology Index (sterling adjusted) was up 4.9%.

Biotech outperformed the general markets in July – the healthcare sector benefited from investors pricing in expectations of a near-term Federal Reserve interest rate cut given a lower-than-expected inflation rate reported for June. Outside the sector, shaky second-quarter earnings performance from consensus trades in Big Tech stood in contrast to better-than-expected earnings updates from less-crowded healthcare names, leading to investment rotation into healthcare names that have underperformed year-to-date. We believe the valuation recovery in small and midcap biotech is underway and should continue in the months ahead.

One public M&A transaction was announced in July. In an all-cash deal, Eli Lilly announced that it would buy all the outstanding shares of Morphic Holding at \$57 per share, a nearly 80% premium to the stock's last closing price before the announcement. Lilly will gain access to Morphic's most advanced asset, MORF-057, currently in three mid-stage studies for the treatment of inflammatory bowel disease. The Company held Morphic stock at the time of the acquisition announcement.

Morphic Holding, Argenx, and Amgen were the largest positive contributors to performance during the month. Morphic's stock price appreciated after Eli Lilly announced plans to acquire the company for \$3.2 billion. Argenx's stock rallied after the company presented encouraging Phase 2 data in Sjogren's syndrome and reported above-consensus Vyvgart sales in its second quarter earnings. Amgen outperformed in anticipation of Phase 2 data from its obesity drug MariTide expected in late 2024. Amgen is moving MariTide into a broad Phase 3 program based on an interim analysis of a Phase 2 trial.

Biogen, Sarepta Therapeutics, and ALX Oncology were the largest negative contributors to performance during the month. Biogen underperformed in July upon announcement of a negative European regulatory opinion for its Alzheimer's drug Leqembi. Sarepta's share price declined in July, as investors took profits heading into second quarter earnings in early August. The share price of ALX Oncology fell in July after reporting disappointing data in metastatic gastric cancer.

Value Assessment
