Commentary

In June, the NAV per share was down 1.6%, the share price was down 3.9% and the benchmark NASDAQ Biotechnology Index (sterling adjusted) was up 0.8%.

Amgen, Xencor, and Gilead Sciences were the top positive contributors to performance during the month. The favorable contribution from Amgen is mainly due to the weakening of the Sterling following the Brexit vote, as Amgen is the largest position in the portfolio. Additionally, Amgen reported positive Phase 2b data of AMG-334, an anti-CGRP antibody for chronic migraine. Xencor shares were strong following the announcement of a partnership with Novartis to develop bispecific antibodies. Gilead shares outperformed due to a favorable court ruling on the patent litigation with Merck and the approval of Epclusa, a pan-genotypic drug for hepatitis C.

Alexion and Biogen were the largest negative contributors to performance during the month. Alexion shares underperformed following the release of Phase 3 results for Soliris in myasthenia gravis which missed the primary endpoint despite showing clinically meaningful efficacy on secondary endpoints. Biogen shares were weak due to the announcement of negative data from its Phase 2 trial of anti-LINGO-1 therapy for multiple sclerosis.

Portfolio Manager Profile

Portfolio management services are provided by OrbiMed Capital LLC (OrbiMed). OrbiMed is owned by six principals, including Samuel D. Isaly and Geoffrey Hsu. The U.S.-based firm employs over 80 experienced investment professionals who between them have extensive scientific, medical, financial and operational expertise. They employ a bottom-up stock selection process driven by intensive proprietary research, which involves company visits and developing an understanding of commercial prospects and development programmes for individual drugs. The firm covers some 600 international pharmaceutical and biotechnology companies, two thirds of which are actively OrbiMed is registered as an researched. investment adviser under the U.S. Securities and Exchange Commission (SEC). SEC registration does not imply a certain level of skill or training.

Investment Policy

In order to achieve its investment objective, the Company invests in a diversified portfolio of shares and related securities in biotechnology companies on a worldwide basis. The Company will not invest more than 15%. of the value of its gross assets in any one individual stock at the time of acquisition. It will not invest more than 10%. of the value of its gross assets in direct unquoted investments at the time of acquisition. This limit does not include any investment in private equity funds managed by the Portfolio Manager or any affiliates of such entity. Up to US\$15m, after the deduction of proceeds of disposal and other returns of capital, may be invested in private equity funds managed by OrbiMed Capital LLC or an affiliate. The Company's borrowing policy is that borrowings will not exceed 20%. of the Company's net assets. The Company may be unable to invest directly in certain countries. In these circumstances, the Company may gain exposure to companies in such countries by investing indirectly through swaps. Where the Company invests in swaps, exposure to underlying assets will not exceed 5% of the gross assets of the Company at the time of entering into the contract.

Discount Control Mechanism

The Directors have adopted an active discount management policy to establish and support an improved rating in the Company's shares through the use of share buybacks, with a view to limiting the discount to NAV per share at which the shares trade to no more than 6%.

The Biotech Growth Trust PLC conducts its affairs so that its shares can be recommended by independent financial advisers ("IFAs") to retail private investors. The shares are excluded from the Financial Conduct Authority's ("FCA's") restrictions which apply to non-mainstream investment products because they are shares in a UK-listed investment trust.
